In this case study, an investment group engaged CPL Business Consultants to conduct an investment overview of a diversified ingredients company. This information was used to inform the investment thesis and supported productive discussions with the company's management.

The objective of this study was to assist our client in its assessment of a diversified ingredients company, with a view to investing in it. In particular, the client sought to understand the target's business and product categories as well as the competitors and markets for these products. The aim was to provide sufficient information for an investment thesis to ensure productive discussions with the company's management on the benefits and potential of external investment.

Firstly, CPL reviewed the diversified ingredients company's portfolio of products, which included segmenting the different product categories, identifying competitors and reviewing any substitution threats. CPL then researched 15 of the key players in relevant markets, providing an overview of each and highlighting the growth strategies they had followed. This information was used to illustrate the strategic roadmap which could be followed.

Furthermore, CPL collated supporting information on players and products and trends in the market. Based on all the information collected, CPL then provided the client with options for adding value to the diversified ingredients company as well as suggestions for potential bolton acquisitions for inorganic growth.
